- ____ ____ Producing Television Programming is an "Adult" activity. I will be working with adults and will be expected to behave in a responsible adult-like manner.

- ____ ____ I am expected to be respectful of the instructor and my other classmates whenever I take workshops at Access Sacramento. I will not disrupt the class and disturb the other students who have also paid and are trying to learn to use the equipment.
